## **Region 4 Telemental Health Landscape in Response to COVID-19**

With HHS Region 4 public schools closed for the remainder of the 2019-2020 school year, students are particularly vulnerable and may be at increased need for mental health services. State and federal authorities have enacted numerous reforms and extended sizeable budget allocations to help fill this need.

- The Coronavirus Aid, Rehabilitation, and Economic Security Act (CARES Act) sets aside [\\$13.2 billion for K-12 schools](#) for services that include telemental health delivery to youth. The package also provides an additional \$100 million (through [US DOE Project SERV](#)) to support services such as mental health counseling.
- Region 4 State Medicaid agencies have expanded telemental health coverage by waiving restrictions on payment for services which require that the provider and patient be located at the same physical location at the time of the service.
- Some state mental health licensing boards have effectively expanded the workforce available to provide services by waiving restrictions on out-of-state licensed providers and clinical student providers.

This document presents a general landscape of state mental health licensing board responses to the COVID-19 public health emergency related to telemental health services and payment. It is important to note that many of these provisions are time-sensitive, and so may not remain in effect beyond the listed dates (or the date when states declare the end of the COVID-19 public health emergency).

<sup>2</sup> Funds are distributed to schools most impacted by COVID-19: 60% distributed based on share of national school-aged youth (i.e., 5-24 years); 40% based on share of Title I youth.

<sup>3</sup> Medicaid state offices have removed reimbursement site restrictions based on where the provider and patient are at the time of service.

<sup>4</sup> Requires private payers to reimburse telehealth services at the same rate as in-person services.
