

# *NCAI COVID19 RELIEF APPLICATION*

## **Overview & Purpose**

With the continued spread of the novel coronavirus (Covid-19), and the tribal, federal, and state directives issued to prevent further transmission, NCAI is committed to supporting Indian Country and lifting up our communities as we continue to combat this global pandemic. Keeping in mind the needs of our tribal nations. NCAI is awarding \$5,000 to various tribal nations and Native serving entities that have been effected by this pandemic.

Your complete application must include the information requested in Part 1, and Part 2, of this application form. The NCAI Review Committee will consider all applications that are submitted by eligible applicants by the deadline, and which are complete and conform to the application guidelines below.

## **Eligibility**

In order to be eligible for this NCAI COVID19 Fund, the applicant must meet following criteria:

- Be a federally recognized Indian tribe or state recognized tribe, Tribal Nursing Home Facility, Tribal College or Tribal University, or a Native serving organization with a 501C3 status.
- Funds must be obligated within six months.
- A selected tribal nation must submit a follow up report to NCAI, a template will be provided.

## **Application Guidelines**

- **Deadline:** Applications will be reviewed on a rolling deadline until all funds are distributed.
- **Amount of Requests:** Grants will be capped at \$5,000.
- **Submission:** Submit your completed application along with your W9 to [kroyal@NCAI.org](mailto:kroyal@NCAI.org).
- **Application Length:** The completed application for Part 1 and Part 2 below should range between 2 to 3 pages in length total. .
- **Application Format:** The application should be completed in size 12 font, Times New Roman, and be single-spaced.

NCAI will give priority to applicants on a first come first serve basis.
