# **Great Lakes MHTTC School Supplement**

The Great Lakes Mental Health Technology Transfer Center (MHTTC) School Supplement is a one-year project (through August 2019) that provides training and technical assistance to **support school-based mental health services**.

#### **Great Lakes MHTTC**

The Great Lakes MHTTC, funded by the Substance Abuse and Mental Health Services Administratin (SAMHSA), will provide high-value training and technical assistance targeted to local needs school-based mental health in HHS Region 5 (Illinois, Indiana, Michigan, Minnesota, Ohio, and Wisconsin).

The MHTTC Network includes a Network Coordinating Office (NCO), ten MHTTC Regional Centers, a Tribal Affairs Center, and a Hispanic and Latino Center. Our collaborative network supports resource development and dissemination, training and technical assistance, and workforce development for schoolbased mental health and safety initiatives. The MHTTC Network will work with organizations and treatment practitioners involved in the delivery of mental health services to strengthen their capacity to deliver effective evidence-based practices to youth, including the full continuum of services spanning mental illness prevention, treatment, and recovery support.

# **Our Goals**

The goals of the Great Lakes MHTTC are to:

- Accelerate the adoption and implementation of evidence-based practices.
- Heighten the awareness, knowledge, and skills of the workforce.

- Develop strategies for delivering culturallyinformed care with diverse practitioners, researchers, policy makers, family members, and consumers of mental health services.
- Increase access to publicly available, free-ofcharge training and technical assistance for the school-based mental health field.

#### What Services We Will Offer

Areas of focus for the **Great Lakes MHTTC School Supplement** include:

- Promoting a comprehensive schoolbased mental health framework
- Integration of mental health treatment into schools and other healthcare settings
- Implementing evidence-based practices for school-based mental health
- Process improvement for school-based mental health care settings
- Culturally competent service delivery

- Increase the # of programs, schools, organizations, and communities that implement evidence-based mental health-related practices and activities.
