DRM (https://drme.org/mental-health) provides advocacy services to individuals with mental illness under the Protection and Advocacy for Individuals with Mental Illness, or PAIMI, program. The federal PAIMI statute and related regulations provide that the rights of individuals with mental illness are protected, instances of abuse and neglect are investigated, and that organizations such as DRM can engage in outreach and monitoring activities.

MASSACHUSETTS

While Massachusetts does not have a statute for PAD, the state does have laws related to appointing a healthcare proxy. A healthcare proxy is a person that you appoint to oversee making physical and mental healthcare decisions when a clinician deems that you are unable to make them for yourself.

Disability Law Center (DLC)

A *health care proxy* is a simple legal document that allows you to name someone who can make healthcare decisions on your behalf if you are unable to make or communicate those decisions for yourself.

NEW HAMPSHIRE

New Hampshire does not have a statute for psychiatric advance directives, but the state does have a statutory durable power of attorney. With a Durable Power of Attorney for Health Care, individuals can appoint a person to act as their agent and make healthcare decisions for them if they are unable to make decisions for themselves.

Disability Rights Center-New Hampshire (DRC-NH)

Disability Rights Center–New Hampshire (https://drcnh.org) is the state's designated Protection and Advocacy agency, which provides information, referral, advice, legal representation, and advocacy to individuals with disabilities on various disability-related problems including special education, accessibility, employment discrimination, homeand community-based services, and Medicaid. DRC–NH addresses systemic issues using litigation, investigations, monitoring, and other policy change efforts, which focus on improving the lives of people with disabilities across New Hampshire.

There is no statute for PADs in Rhode Island, but residents can designate a person to make healthcare decisions for them if they are unable to make choices for their own care.
