### Helping Pharmacists Help our Kids

We have talked before about how COVID-19 has kept parents from their pediatricians' offices with the resulting scary decrease in kids getting their childhood vaccines. Well, today HHS used an emergency authority to help address this by <u>issuing a third amendment</u> to the <u>Declaration under the Public Readiness and Emergency Preparedness Act (PREP Act) to increase access to lifesaving childhood vaccines and decrease the risk of vaccine-preventable disease outbreaks as children across the United States return to daycare, preschool and school. The amendment authorizes State-licensed pharmacists (and pharmacy interns acting under their supervision to administer vaccines, if the pharmacy intern is licensed or registered by his or her State board of pharmacy) to order and administer vaccines to individuals ages three through 18 years.</u>

#### FDA EUA for LumiraDx UK Ltd.'s SARS-CoV-2 Antigen Test

This week the FDA granted an Emergency Use Authorization (EUA) for LumiraDx UK Ltd.'s LumiraDx SARS-CoV-2 Ag Test and <u>Assistant Secretary for Health Admiral Brett P. Giroir, M.D., released a statement on the test</u>. LumiraDx is a rapid point-of-care antigen test at is used with the LumiraDx Platform for the detection of SARS-CoV-2 directly from nasal swab specimens.

### COVID-19 Among American Indian and Alaska Native Persons

CDC released an MMWR on COVID-19 Among American Indian and Alaska Native Persons from January 31 to July 3, 2020. American Indian and Alaska Native (Al/AN) persons appear to be disproportionately affected by the COVID-19 pandemic; however, limited data are available to quantify the disparity in COVID-19 incidence, severity, and outcomes among Al/AN persons compared with those among other racial/ethnic groups. In 23 states with adequate race/ethnicity data, the cumulative incidence of laboratory-confirmed COVID-19 among Al/AN persons was 3.5 times that among non-Hispanic white persons. A large percentage of missing data precluded analysis of some characteristics and outcomes. CDC also released a press release in response to this MMWR on the more than \$200 million provided to address COVID-19 health disparities in Indian Country.
