# ALABAMA

## **STATE LEGISLATURE APPROPRIATION (2020)**

4.5M allocated to employ  $\rm MH^1$  Service Coordinators, who coordinate MH programs and services at the school district-level

\$1.75M (\$1M + \$.75M) allocated to the School MH Collaboration Program to place additional master's-level therapists on school grounds



# **FLORIDA**

## HB 945: IN EFFECT (JUN 2020)

Requires de-escalation procedures and contact with crisis response teams before removing from a school any student posing immediate threat to themselves or others

## FY2021 BUDGET: IN EFFECT (JUN 2020)

Appropriates \$100M to help schools establish or expand school-based MH services and allocates another \$4M to improve tele-mental health for schools others

# **GEORGIA**

# FY 2021 BUDGET ITEM: CONSIDERED, NOT PASSED (JUNE 2020)

Would have appropriated \$25M to finance additional MH providers in schools to meet a minimum counselor-to-student ratio of 1:450

# **KENTUCKY**

## **SB 8: IN EFFECT (FEB 2020)**

Specifies goals for SB 1 (a major 2019 state law on school safety and school-based MH services):  $\geq$  1 school counselor per public school and  $\geq$  1 counselor or school-based MH provider per 250 students

## HB 352: IN EFFECT (MAY 2020)

Appropriates \$7.4M in FY2021 to finance placement of school-based MH providers

#### **HB 434: UNDER CONSIDERATION**

Would appropriate \$4M (recurring, 2020-2022) to pay for MH screenings



## **MISSISSIPPI**

# HB 770 (THE TRAUMA-INFORMED DISCIPLINE PRACTICES ACT) CONSIDERED, NOT PASSED (JUN 2020)

Would have required trauma-informed training for school staff and formed a special committee to develop recommendations for school MH services



# **NORTH CAROLINA**

## HB 1043 (2020 COVID-19 RECOVERY ACT): IN EFFECT (MAY 2020)

Allocates \$10M to pay for additional school health and MH services in response to COVID-19 (including remote services), effective Mar–Dec 2020

## SB 476: IN EFFECT (JUN 2020)

Requires K-12 schools to adopt a school-based MH plan, including a youth MH training program and a suicide risk referral protocol for school personnel; no funding attached

# SOUTH CAROLINA

## **HB 4662: UNDER CONSIDERATION**

Would mandate that schools may not prohibit school behavioral health providers from serving students during school hours, if parents requested such services

# **TENNESSEE**

## FY 2021 BUDGET: IN EFFECT (JUN 2020)

Appropriates \$3M to expand School-Based Behavioral Health Liaisons to all 95 counties, to provide training and education for school personnel on behavioral health topics and to implement Tiers 1-3 services

## HB 2756: CONSIDERED, NOT PASSED (MAY 2020)

Would have established the Basic Education Program to finance  $\geq$  1 full-time MH counselor per school
