

Resources to Address School Violence

Findings from an Environmental Scan and Gap Analysis

The Ask

In 2022, the Mental Health Technology Transfer Center (MHTTC) Network, funded by the Substance Abuse and Mental Health Services Administration (SAMHSA), was asked to amplify and disseminate existing programming and resources related to school violence for the school mental health workforce (e.g., crisis intervention teaming, school violence trauma and grief response, cultural considerations for school violence), and develop responsive training and technical assistance to address additional needs identified. Through the <u>MHTTC School Mental Health Initiative</u>, the MHTTCs and MHTTC Network Coordinating Office led a national effort to respond to this request.

Our Goals

We worked together to conduct an environmental scan and gap analysis, through which we aimed to 1) compile existing programming/resources on school violence, especially those developed by the MHTTCs and other SAMHSA-funded organizations; 2) identify the gaps that exist in school violence-related programming/resources available in the field; and 3) consider the development of new training, technical assistance activities, and/or resource(s) with a focus on addressing the gaps identified via the environmental scan and gap analysis.

Defining School Violence

We found value in first identifying a definition for school violence that we could refer to throughout the environmental scan process. We purposefully searched for a definition that is in alignment with what many school systems may already reference. We also wanted the definition to reinforce that school violence includes physical, emotional, mental, and social-behavioral forms of violence. We moved forward with the definition below, developed by the Centers for Disease Control and Prevention (CDC) Divisions of Violence Prevention and Adolescent and School Health:

School violence is violence that occurs in the school setting. It describes violent acts that disrupt learning and have a negative effect on students, schools, and the broader community. School is the location where the violence occurs, not a type of violence. Examples of school violence include bullying and cyberbullying; fighting (e.g., punching, slapping, kicking); weapon use; gang violence; and sexual violence (CDC, 2021).

Our team also emphasized that school violence includes the following components:

- Structural violence, racial violence, and violence targeted at young people with minoritized identities (including gender, LGBTQ+ identity, refugee, asylum seeker, undocumented status or other immigration status, socioeconomic status, etc.)
- Discriminatory acts and the lack of understanding and absence of compassion towards diversity
 manifested in any shape or form to denigrate a person's dignity

Our Process

With a school violence definition solidified, we then identified inclusion criteria for the resource screening process. We came to a consensus on the following inclusion criteria:

- Action-oriented and strengths-based (such as resources that address *what* is working to prevent/decrease violence, *how* schools can create positive school environments, etc.)
- Address factors across the prevention, intervention, and/or postvention continuum
- · Practice or program-focused and/or informational or awareness-focused
- Highlight an evidence-based practice/program, best & promising practice/program, and/or culturally-adapted practice/program
 - We utilized the following definition for evidence-based practices/programs: "Interventions for which there is scientific evidence consistently showing that they improve client outcomes" (Drake et al., 2001, p.1).
 - We utilized the following definition for best and promising practices/programs: "Programs and strategies that have positive, scientific outcomes for improving behavioral health" (MHTTC Network, 2021).
 - We utilized the following definition for culturally-adapted practices/programs: "The systematic modification of an evidence-based treatment or intervention protocol to consider language, culture, and context in such a way that it is compatible with the client's cultural patterns, meanings, and values" (Bernal et al., 2009, p. 362).
- · Developed in the last 20 years
- · Based in the United States
- Targeted towards K-12 schools/student populations
- Free/no cost
- Intended audience for school mental health providers such as school counselors, social workers, psychologists, and other mental health professionals (those hired by the school and those who work for a community organization and come into the school to provide school mental health services); educators, administrators, school resource officers, and mental health peer leaders

From there, we created a tracker to organize and document all resources compiled and then we began our search. We conducted our search by:

- Scanning the MHTTC Network's Products and Resources Catalog.
- Scanning websites of mental health organizations, especially SAMHSA-funded organizations and MHTTC Network partners & collaborators, that may offer resources related to school violence and student mental health.
- Disseminating a national survey to the MHTTC Network's external contacts, inviting them to submit relevant and no-cost school violence-related prevention, intervention, and postvention resources they utilize/are aware of.

After documenting the MHTTC-developed resources, external resources, resource lists of interest, and organizations of interest that we identified via our search, we conducted a second review of the resources compiled to ensure inclusion criteria were indeed met.

Note: Due to time constraints, we did not screen individual resources available within comprehensive resource lists that were compiled by organizations with a main focus on school violence (e.g., SchoolSafety.gov, National Center for School Safety). Instead, we documented where the resource lists could be accessed to ensure we amplify them to our audience via this findings summary.

Of the 61 MHTTC-developed and external resources reviewed, more than half are virtual learning sessions (61%), followed by guides (15%). The remaining resource types (e.g., tip sheet, slide deck, training program, and online course) make up less than 10% of the reviewed products.

Of the 61 MHTTC-developed and external resources reviewed, 100% of guides, online courses, and slide decks highlight an evidence-based practice and 75% of the training programs highlight an evidence-based practice. Further, more than half of the reviewed virtual learning sessions and tip sheets highlight an evidence-based practice as well.

Of the 61 MHTTC-developed and external resources reviewed, all of the online courses, slide decks, and training programs highlight a best and promising practice. Nearly 90% of virtual learning programs highlight a best and promising practice.

Of the 61 MHTTC-developed and external resources reviewed, only about one-third highlight a culturally-adapted practice.

The MHTTC resources reviewed are primarily intervention and postvention-focused. The external resources reviewed are primarily prevention and postvention-focused.

The majority of the resources reviewed are considered practice and program-focused. Only 20% of the reviewed materials are considered to be solely informational or awareness-focused.

Our Recommendations

1

Overall, the review of resources found a wide array of evidence-based or promising practices that were strengths-based and action-oriented to address violence in schools from prevention, intervention, and postvention stages. It is recommended that the MHTTC Network work collaboratively to publish the resources identified via this work in a concise and user-friendly resource collection format, to ensure easy access to school violence-related resources in one place.

The review of resources also revealed a need for school violence preventionfocused resources. It is recommended that the MHTTC Network work together to aim efforts in developing resources that aim to support school violence prevention efforts. Based on the review, there is a need for resources that synthesize information in concise and engaging formats (interactive guides, tip sheets, etc.). It is recommended that the MHTTC Network work together to aim efforts in developing school violence prevention resources that fall into those categories.

Lastly, this review found a large gap in resources that have been culturally adapted to meet the needs of specific populations served in schools. It would be beneficial for the MHTTC Network to aim to disseminate existing culturally adapted and population-specific practices that address violence in schools, while also partnering with experts to develop and disseminate additional programs or practices that include cultural, linguistic, and population-specific adaptations to best serve all students and families.

Next Steps

The MHTTC Network remains committed to bringing awareness to student mental health, disseminating information on student mental health and evidence-based school mental health supports and services, and providing technical assistance and training on the implementation of mental health services in schools and school systems. With additional funding received to continue our MHTTC School Mental Health Initiative in 2023-2024, our goal is to work collaboratively to develop resources, training, and technical assistance that are responsive to the aforementioned recommendations from our environmental scan and gap analysis.

In addition, we intend to publish a resource collection on our <u>website</u> that highlights the resources, resource lists, and key organizations identified through our work in an effort to continue disseminating and amplifying them to the school mental health workforce. In the meantime, the pages that follow highlight the free resources and resources lists, as well as organizations of interest that provide free resources, that we compiled through our environmental scan.

Readiness and Emergency Management for Schools (REMS) Technical Assistance (TA) Center	The REMS TA Center is the nation's higher ed and K-12 school safety, security, and emergency management and preparedness hub for information and services. The REMS TA Center serves K-12 schools and institutions of higher education as well as their local, state, and Federal partners with shared school safety responsibilities. They develop and maintain comprehensive, all-hazard, and high-quality campus and school Emergency Operations Plans. These plans focus on continually protecting the whole school community before, during, and after possible emergencies. The REMS TA Center offers free virtual trainings, guides, resources, and tools including interactive tools which help generate customized plans (e.g., EOP Assist Software), and a SITE ASSESS app which facilitate the walk-through and safety inspection of campus and buildings.
Sandy Hook Promise	The Sandy Hook Promise aims to protect America's children from gun violence in honor of the lives lost at Sandy Hook Elementary School. The Sandy Hook Promise provides training and resources to prevent gun violence in schools including distance learning about violence prevention, online social emotional learning, virtual training for school shooting prevention, school safety lesson plans, and violence prevention worksheets for schools.
School Crisis Recovery and Renewal	The SCRR website provides resources and tools for advancing school crisis readiness, response, recovery, and renewal work. A variety of guides, toolkits, tip sheets, and other products are available addressing topics related to school violence and beyond.
SchoolSafety.gov	SchoolSafety.gov was created by the federal government to provide schools and districts with actionable recommendations to create safe and supportive learning environments for students and educators. Resources available address topics such as bullying and cyberbullying, school climate, threat assessment and reporting, and targeted violence.
Stopbullying.gov	Stopbullying.gov provides resources and supports for schools to help prevent and respond appropriately to bullying as well as supports for children being bullied or witnessing of bullying.
Substance Abuse and Mental Health Services Administration (SAMHSA)	SAMSHA is the agency within the U.S. Department of Health and Human Services that leads public health efforts to advance the behavioral health of the nation. Resources are available related to school violence and bullying using the search function on the homepage.

The National School Climate Center (NSCC)	The NSCC promotes safe, supportive learning environments that nurture social and emotional, civic, and academic growth for all students. The NSCC provides professional development, a school climate leadership certificate, consultation services, resources, measurement tools designed to quantify the school climate, and services to address bullying prevention.
